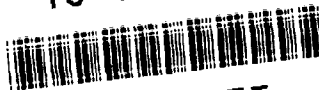


ASSIGNMENT

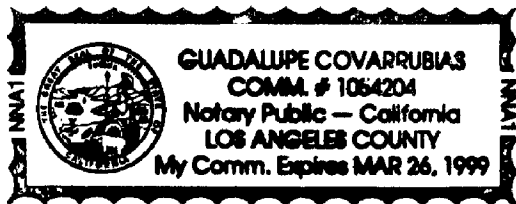
