1. The Designer and Company **HEREBY ASSIGN** to the Assignee all copyright, design and other such rights, whether registered or unregistered together with all and any other benefit, right, title and interest ("the Rights") in the Designs which the Designer and/or the Company now or at any time hold or held wheresoever the Rights may subsist for the residue of their term and any renewals and extensions thereof **TO HOLD** the same unto the Assignee absolutely together with all and any other benefit, right, title and interest therein including the right to take action anywhere in the world for past infringements and to recover damages including (where available) damages for conversion or detention of the infringing copies, additional, aggravated and exemplary damages and all other remedies in respect of any infringement of the said rights.

such documents and perform all such further acts as may be necessary to vest absolutely in the Assignee the Rights and other benefit, right, title and interest as aforesaid.

3. The Designer and Company hereby also undertake to give all reasonable assistance requested by directly or indirectly or on its behalf in any proceedings relating to the designs and undertake to reimburse the Assignee for all reasonable expenses incurred in giving such assistance.
4. The Designer and Company severally warrant that, in so far as the designs or any parts thereof were made by any employee of the Designer or the Company, such were made by the employee in the ordinary course of his full time employment with the Designer or the Company under terms which did not preclude the Rights vesting in the Designer or the Company.
5. The Designer and Company warrant in favour of the Assignee that the designs are original and that immediately prior to the execution hereof the rights granted by virtue of this Assignment vested in the Designer and/or the Company and that nothing has been done nor has any event occurred whereby such rights or any of them may be declared void or terminated.
6. The Designer and Company covenant in favour of the Assignee that the Assignee shall have and enjoy quiet possession of the rights granted herein uninterrupted and undisturbed by the Designer or the Company or any other party claiming through, under or in trust for the Designer and/or the Company.
7. The Designer and Company further warrant that to the best of the Designer's and Company's knowledge and belief the grants granted herein do not infringe the rights of any third party.

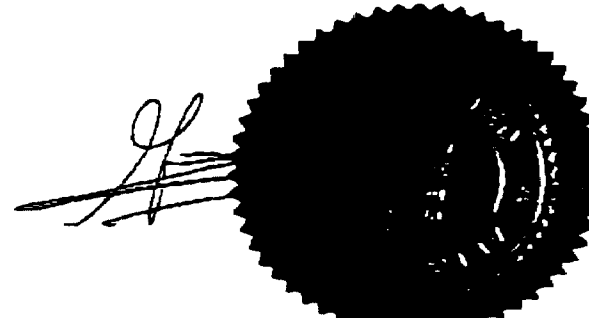
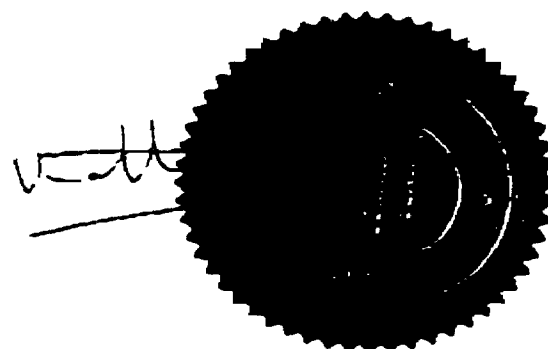
