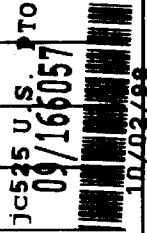

Assignment made this 30 day of September, 1998, by Kimberlee Thompson, Barbara Wagner and Ming Xu, of the County of Charleston, State of South Carolina, herein referred to as inventors, to Sawgrass Systems, Inc., a South Carolina Corporation, with its principal place of business in the Town of Mt. Pleasant, County of Charleston, State of South Carolina, herein referred to as assignee.

RECITALS

A. Inventors have invented certain new and useful improvements concerning **REACTIVE INK PRINTING PROCESS**, the invention being described in and identified by an application for United States Letter Patent being filed herewith.

B. Assignee is desirous of acquiring the entire right, title, and interest in the application and the invention and improvements thereon, and in letters patent thereon when granted in the United States and foreign countries.
