ASSIGNMENT

WHEREAS, We, **Helga Drescher**, a German citizen, residing at Grabenweg 8/1, Feldkirch, Austria A-6800, **Martin Frank**, a German citizen, residing at In der Fina 16, Schaan, Liechtenstein FL-9494, **Volker Rheinberger**, a Liechtenstein citizen, residing at Mareestr. 34, Vaduz, Liechtenstein FL-9490, and **Wolfram Höland**, a German citizen, residing at Im Aescherle 26, Schaan, Liechtenstein FL-9494, have invented certain new and useful improvements in **ALKALI SILICATE GLASS** for which we have executed an application for Letters Patent in the United States, filed as U.S. Serial No. **09/097,189**, filed **June 12, 1998**;




