## ASSIGNMENT

After execution of this assignment, ownership of the patent rights shall be as tenants in common in the following proportions:

Frederick M. Wise	50%
Raymond R. Sainz	50%

Capitol further agrees to cooperate with Wise and Sainz hereunder in the obtaining and sustaining of any and all such Letters Patent, but at the expense of Wise and Sainz.

The Commissioner of Patents is hereby authorized and requested to issue the Letters Patent solely in accordance with the terms of this Assignment to Wise and Sainz, their successors, legal representatives and assigns of the entire right, title and interest

therein.
