The Assignees agree to negotiate, sell, assign or encumber an interest or right in said patent only with their joint written consent.

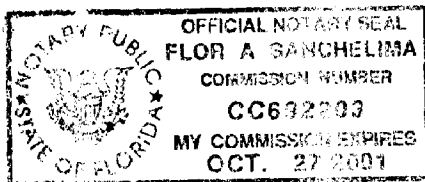
