And, for the above consideration, I hereby covenant and agree that I will, at the request of said CTS CORPORATION, its successors, legal representatives and assigns, execute any and all renewal, continuation and divisional applications, both United States and foreign, for Letters Patent for said invention; and any and all applications for the renewal, the reissue and the extension of any Letters Patent, both United States and foreign, that may be granted for said invention and do any and all other and further acts to obtain any such Letters Patent, and any renewal, any reissue and any extension of the same that said CTS CORPORATION, its successors, legal representatives and assigns may deem necessary or expedient, without further compensation, but at the expense of said CTS CORPORATION, its successors, legal representatives and assigns.
