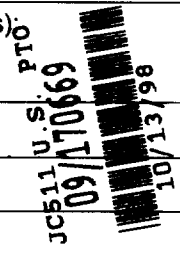



ASSIGNMENT OF PATENT APPLICATION
