WHEREAS, we, Geoffrey J. Schmidt and Kenneth L. Hoffman have invented a certain improvement in "A-Protein as a Diagnostic of Cancer" described in U.S. National Phase of International Application No. PCT/US96/00098, filed July 10, 1997.
