

WHEREAS, we, the undersigned, have made new and useful inventions and improvements in COMPOSITION AND METHOD FOR TREATMENT OF PSORIASIS for which an application for Letters Patent of the United States was filed on August 28, 1998, which application is identified as U.S. Serial No. 09/143,146 (Pearne, Gordon, McCoy & Granger Docket No. 30613US1).
