assigns and nominees, to obtain and enforce proper protection for said invention in the United States of America and its territorial possessions.

Said invention and application to be held and enjoyed by the said TharTech Inc. for its own use and behoof, and for its legal representatives or assigns, to the full end of the term for which any Letters Patent may be granted as fully and entirely as the same would have been held by PhalTech Corporation had this assignment and sale not been made.

Laubscher, Sr., attorneys of record, are hereby granted the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark office for recordation of this document.
