This Assignment made by me, James Moore Schenck, hereinafter referred to as assignor, citizen of the United States of America, residing at 2421 Merrimont Drive, City of Winston-Salem, County of Forsyth, State of North Carolina.

WITNESSETH: That,

WHEREAS, I am the sole inventor of certain new and useful improvements in a **CENTERLINE DETECTOR FOR A TUBULAR KNIT FABRIC LAY CUTTER** for which I have made an application for Letters Patent of the United States, application serial number 09/135,116, filed August 17, 1998; and

entirely as the same would have been held and enjoyed by me had this assignment and sale not been made.

And for the consideration aforesaid, I hereby covenant and agree to and with the said assignee, its successors and assigns, that at the time of the execution and delivery of these presents I am the sole and lawful owner of the entire right, title and interest in and to the invention, application and Letters Patent above-mentioned and that the same are unencumbered, and that I have good right and lawful authority to sell and convey the same in the manner herein set forth.


I hereby request the Assistant Commissioner for Patents to issue the Letters Patent in accordance with this instrument.
