ASSIGNMENT OF PATENT APPLICATION

WHEREAS WE:

Anne Geraldine O'Connell, a citizen of Ireland, residing at 3 Woodberry, Carpenterstown Road, Dublin 15, Ireland and Mark Anthony Hughes, a citizen of Ireland, residing at 16 Grange Park Avenue, Raheny, Dublin 5, Ireland, (hereinafter ASSIGNORS) have invented new and useful improvements in:

LAST-IN FIRST-OUT DATA STACKS AND PROCESSING DATA USING SUCH DATA STACKS

for which an application for a patent for said invention in the United States of America is currently being executed and in respect of which an earlier application was filed as follows:
