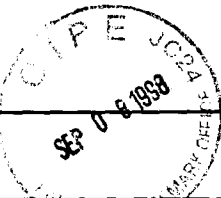

documents which, in the opinion of counsel for said Captive Fastener Corporation, its successors and assigns, may be required or necessary to more effectively secure to and vest in said Captive Fastener Corporation, its successors and assigns, the entire right, title and interest in and to said invention and improvements, applications, Letters Patent, rights, benefits, privileges and advantages hereby sold, assigned, transferred and conveyed, and that I will sign any applications for reissue which may be desired by the owner of the patent or patents which may be issued for the said invention or improvements.
