

## ASSIGNMENT

WHEREAS, I, Thomas W. Stone, residing at 1605 Main Street, Bethlehem, PA 18018, (hereinafter referred to as "Assignor") have made an invention entitled OPTICAL SWITCHING, ROUTING, AND TIME DELAY SYSTEMS USING SWITCHED MIRRORS, for which an application for a United States Patent was filed on June 22, 1998 and accorded Serial Number 09/102,700.

Assignor hereby authorizes and requests the Commissioner of Patents of the United States, and any official of any country or countries (including multinational filing arrangements of all kinds), whose duty it is to receive and/or examine applications for patents or similar industrial property, issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to Assignee, its successors and assigns, in accordance with the terms of this instrument.

Assignor further covenants and agrees to communicate to Assignee, its successors, legal representatives and assigns, any facts known to Assignor respecting said invention, and testify in any legal proceeding, sign all lawful papers, including, without limitation, application papers, assignments, powers of attorney, declarations, and other instruments, execute all divisional, continuing, substitute, reissue, renewal and foreign applications, make all truthful oaths, declarations and statements, and generally do everything reasonably requested of Assignor by Assignee, or its successors or assigns to aid Assignee, its successors or assigns, to obtain, enforce and /or exploit said invention.
