We hereby authorize and request the attorneys appointed by us in said application to record on this assignment the Serial No. and filing date of said application when such are ascertained.



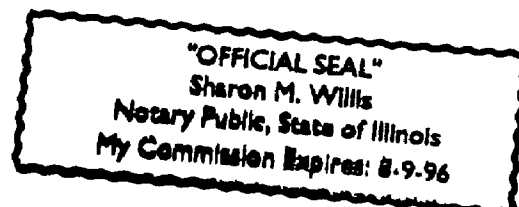
