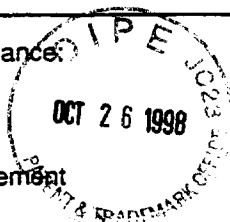

Thompson, President of, and acting for THOM-MCI, INC., have sold, assigned, transferred and set over to ATLANTIC-MEECO, INC., the said invention and the Letters Patent aforesaid and any reissue of said Letters Patent, the same to be held and enjoyed by the said ATLANTIC-MEECO, INC, for its own use and enjoyment and the use and enjoyment of its successors, assigns, or other legal representatives, to the end of the term for which said Letters Patent is granted or reissued, as fully and entirely as the same would have been held and enjoyed by THOM-MCI, INC., if this Assignment and sale had not been made, together with all claims for damages by reason of past infringement of said Letters Patent with the right to sue for and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives.



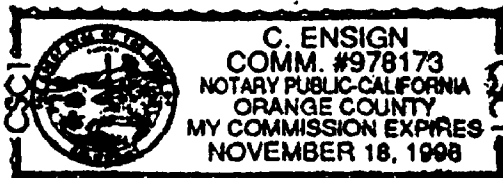
