WHEREAS:

- The Assignor is the applicant named on United States patent application serial number Α. 08/943476 filed on 9 July 1997 and entitled 'Improvements in or Relating to Targeting Systems' ("the Patent Application").
- В. Pursuant to an agreement dated 27th March 1996 between the parties hereto ("the Business Purchase Agreement"), the Assignor agreed to assign the Patent Application to the Assignee and the Assignee agreed to grant to the Assignor a licence to use and exploit the Patent Application and the invention protected by the Patent Application on the terms set out in the Business Purchase Agreement in each case with effect from 1st January 1996 (the "Effective Date").

NOW IT IS HEREBY AGREED AS FOLLOWS:

1. ASSIGNMENT

Pursuant to and in consideration of the benefits specified in the Business Purchase Agreement, the Assignor hereby assigns to the Assignee (subject to any licences granted to third parties in respect of the Patent Application) with effect from the Effective Date all its right, title and interest in and to the Patent Application (including any continuation, division, continuation-in-part or reissue apps and the patents issuing therefrom) and further including all rights, privileges and advantages attaching thereto to hold unto the Assignee absolutely and with the intent that that Assignee shall (i) be absolutely entitled to any patent granted pursuant to the Patent Application for the full term of such patents; (ii) have the right to apply for, prosecute and obtain patent or like protection throughout the world for any invention described in the Patent Application. including the right to claim priority from it; and (iii) have the right to sue for past infringement and obtain damages.

2. LICENCE

Pursuant to the Business Purchase Agreement, the Assignee hereby grants to the Assignor with effect from the Effective Date an irrevocable, non-exclusive, worldwide, royalty-free licence in perpetuity (together with the right to sub-license any other member of the Selling Group as defined in the Business Purchase Agreement for so long as such company remains a member of such Group) to use and exploit the Patent Application, any Patent maturing therefrom, and the invention protected thereby.
