Trademarks to issue said Letters Patent to said STREET SCENE, its successors and assigns, in accordance with this assignment.

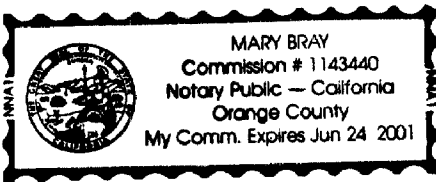
