**WHEREAS, Phillip L. Emery, of Portage, Wisconsin (hereinafter "ASSIGNOR"), has invented a Bedliner With Stiffening Inward Flange, for which application is being made for Letters Patent in the United States, Application No. 08/743,017, filed November 1, 1996; and**

ASSIGNEE any and all additional papers that may be reasonably requested by ASSIGNEE to fully carry out the terms of this Assignment.
