




ASSIGNMENT

WHEREAS, We, **Gerard A. Crispino and Jaidev S. Goudar** of 104 Olympic Court #4, Princeton, New Jersey 08540 and 25-08 Fox Run Drive, Plainsboro, New Jersey 08536, United States of America, have made certain inventions in **PROCESS FOR THE PREPARATION OF A TRIAZOLINONE HERBICIDE** for which, on even date herewith, we have executed an application for United States Letters Patent; and
