WHEREAS, James G. 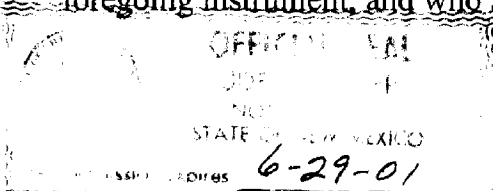
