ASSIGNMENT OF PATENT PROPERTIES

ASSIGNOR FURTHER COVENANTS that upon the request of the ASSIGNEE (or its assigns) ASSIGNOR will promptly provide the ASSIGNEE (or its assigns) with all pertinent facts and documents relating to said applications, said inventions and said Letters Patents and legal equivalents in the United States and foreign countries as may be known and accessible to ASSIGNOR and ASSIGNOR will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue, enforce and perfect such rights, title, and interest in ASSIGNEE, its successors, assigns and legal representatives for said applications, said inventions and said Letters Patents and said equivalents thereof in any foreign country which may be necessary or desirable to carry out the purposes thereof. Any and all reasonable expenses incurred by ASSIGNOR in connection with its obligations under this paragraph shall be paid by the ASSIGNEE (or its assigns).




