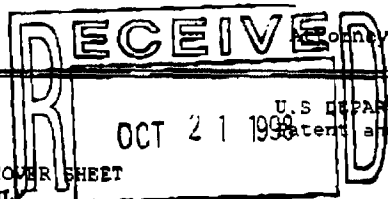

ASSIGNMENT

The Assignor also hereby grants the law firm of EVENSON, MCKEOWN, EDWARDS & LENAHAN, the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
