## A S S I G N M E N T





This assignment and agreement shall be binding upon our heirs and legal representatives.

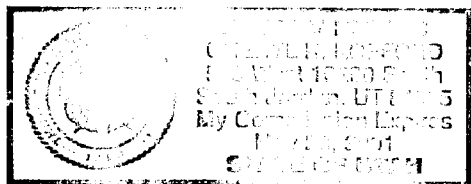
