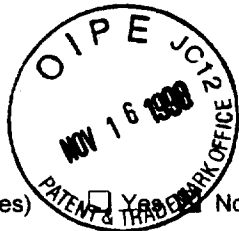

ASSIGNMENT

WHEREAS, We, GLENN D. MOORE of Newfoundland, New Jersey and LESZEK SOLOWIEJ of Montville, New Jersey have invented an invention entitled BATH ACCESSORY POST which we have made application for Letters Patent of the United States of America; and
