Recitals:

- A. I, George Webinger of 3850 Bassett Creek Dr., Golden Valley, MN 55422 have invented certain new and useful inventions and improvements in a Bottle Packaging for which an application for a United States Patent is about to be made, said application having been executed on even date herewith, and which may be identified in the United States Patent Office by Serial No. _____, filed _____.
- B. The Traveling Herbalist, Inc., a Minnesota Corporation having its principal offices at International Square, 6168 Olson Memorial Highway, Golden Valley, MN 55422 (known hereafter, together with its successors and assigns, as the "Assignee") is desirous of acquiring the entire right, title and interest in and to said inventions, improvements and application and in, to, and under any and all Letters Patent to be obtained therefor.

I Agree as Follows:

- 1. For and in consideration of One Dollar (\$1.00) and other good and valuable considerations, the receipt of which is hereby acknowledged, I have sold, assigned and transferred, and by this Assignment do hereby sell, assign and transfer onto the Assignee, my entire right, title and interest in and to said invention, said application and any and all continuations, divisions, renewals and Letters Patent derived therefrom, both foreign and domestic, that may or shall issue based upon the invention, including all my rights under the International Convention.

- 3. I do hereby authorize and request the Commissioner of Patents and Trademarks to issue said Letters Patent to the Assignee in accordance herewith. I further authorize the Assignee, or anyone it may properly designate, to apply for Letters Patent, in its own name, if desired, in any and all foreign countries, and additionally to claim the filing date of said United States application or otherwise take advantage of the provisions of the International Convention.
- 4. I hereby authorize the Assignee or anyone it may properly designate, to insert in this instrument the filing date and Serial Number of said application when ascertained.
- 5. I do hereby covenant that I have and will not execute any writing or do any act whatsoever conflicting with these presents.
- 6. I or my executors or administrators will, at any time upon request, without further or additional consideration, but at the expense of the Assignee, execute such additional writings and do such additional acts as the Assignee may deem necessary or desirable to perfect the assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, reissued or extended Letters Patent of the United States, or of any and all foreign countries on said invention, and in enforcing any rights, occurring as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents.
