ASSIGNMENT

Whereas, George J. E. Boutros, a citizen of USA, residing at 7550 220th Street, Chanute, KS 66720, has invented an invention entitled: "Ophthalmic Instrument and Method for Preparing an Eye fo LASIK", for which he executed an application for Letters Patent of the United States of America on 10/24/98; and

E. Boutros hereby authorizes the Commissioner of Patents and Trademarks to issue all Patents on said United States of America applications arising out of said invention and improvements to said invention to said Kalil M. Jiraki and George J. E. Boutros as assignees thereof.


