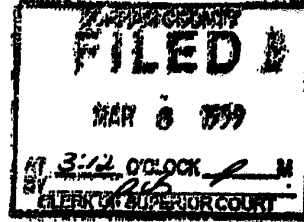

ORDER

THIS CAUSE COMING ON TO BE HEARD before the undersigned Judge of the Superior Court, upon the Plaintiff's Attorney's Motion for Default Judgment.

IT APPEARS THAT good cause exists to allow the Motion.

IT IS THEREFORE ORDERED that the Motion for Default Judgment is allowed and is FURTHER ORDERED that:

(1) Defendant Remote Source Lighting International, Inc. pay to Eric Buckland, as termination pay, a sum in the amount of Eighty-Five Thousand Dollars (\$85,000.00) with interest of at the legal rate from March 8, 1999.

(2) Defendant pay to Eric Buckland, as expenses, a sum in the amount of \$ 33,843.05 and pay, for paid time off, a sum in the amount of \$ 3,167.43.

(3) Defendant provide an accounting to the Plaintiff of the number of shares of voting common stock of the Company, which have vested in Plaintiff pursuant to the Company Incentive Stock Option Plan and Plaintiff is hereby permitted, if Plaintiff so

desires, to purchase these shares at the granted option price of Twelve Dollars (\$12.00) per share.

(4) Defendant pay to Plaintiff (~~punitive~~/treble) damages of \$276,031.44, filing and service costs of \$70.00, and attorney fees to Norman L. Sloan in the amount of \$4,500⁰⁰.
