WHEREAS, I, Martin G. Hoskins, a citizen of the United States of America residing at 110 Brandenberry Road, Brunswick, Georgia 31523, have invented certain new and useful improvements in "Improved Fluffed Pulp and Method of Production", for which an application for Letters Patent of the United States was filed on January 2, 1998, and accorded Serial No. 09/002,348; and

AND I HEREBY warrant and covenant that I have full right to convey the entire interest herein assigned and that I have not executed and will not execute any instrument or assignment in conflict with this Assignment;

AND I HEREBY agree to communicate to said assignee or its representatives any facts known to me respecting said invention, to execute all divisional, continuation, reissue, and foreign applications, sign all lawful documents and make all rightful oaths and declarations relating to said invention, and to testify in any judicial or administrative proceeding and generally do everything possible to aid said assignee to obtain and enforce said Letters Patent in the United States or any foreign country when requested so to do by said assignee.
