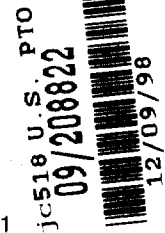

ASSIGNMENT

WHEREAS, We, **Nahum Gitnik and Amos Intrater**, hereinafter referred to as "ASSIGNORS", have invented certain new and useful improvements, as described and set forth in the below-identified application for United States Letters Patent:
