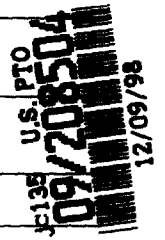

WHEREAS, Myeung-Sik LEE, residing at 308, Shinnam-Li, Namyang-Myun, Hwansung-Kun, Kyungki-Do, Republic of Korea, Soo-Bong PARK, residing at 1404 Ho, Samhwan Apt. 4 Dong, Guwoon-Dong, Kwonsun-Ku, Suwon, Republic of Korea, Won-Kyong CHANG, residing at 808 Ho, Youngkwang Apt 1 Dong, Hwaseo-Dong, Changan-Ku, Suwon, Republic of Korea, Jin-Ki PARK, residing at 108 Ho, Jukong Apt. 425 Dong, Maetan-Dong, Paldal-Ku, Suwon, Republic of Korea, and Yong-Yun PARK, residing at 564-13, Inge-Dong, Paldal-Ku, Suwon, Republic of Korea, have made certain new and useful inventions and improvements for which they have executed an application for Letters Patent of the United States, which is entitled ARTIFICIAL INSEMINATION DEVICE FOR PRIVATE USE, filed of even date herewith;

NOW, THEREFORE, to all whom it may concern, be it known that for and in consideration of the sum of One Dollar and other good and valuable considerations, the receipt and sufficiency whereof is hereby acknowledged, Myeung-Sik LEE, Soo-Bong PARK, Won-Kyong CHANG, Jin-Ki PARK and Yong-Yun PARK have sold, assigned and transferred, and by these presents do sell, assign and transfer unto said Rural Development Administration, its successors or assigns, the entire right, title and interest for all countries in and to all inventions and improvements disclosed in the aforesaid application, and in and to the said application, all divisions, continuations, or renewals thereof, all Letters Patent which may be granted therefrom, and all reissues or extensions of such patents, and in and to any and all applications which shall be filed in any foreign countries for Letters Patent on the said inventions and improvements, including an assignment of all rights under the provisions of the International Convention, and all Letters Patent of foreign countries which may be granted therefrom; and Myeung-Sik LEE, Soo-Bong PARK, Won-Kyong CHANG, Jin-Ki PARK and Yong-Yun PARK do hereby authorize and request the Commissioner of Patents to issue any and all United States Letters Patent for the aforesaid inventions and improvements to said Rural Development Administration, its successors and assigns.

AND, for the consideration aforesaid, Myeung-Sik LEE, Soo-Bong PARK, Won-Kyong CHANG, Jin-Ki PARK and Yong-Yun PARK do hereby agree that their executors and legal representatives will make, execute and deliver any and all other instruments in writing including any other documents, and will communicate to said Rural Development Administration, its successors and representatives all

facts known to us relating to said improvements and the history thereof and will testify in all legal proceedings and generally do all things which may be necessary or desirable to more effectually secure to and vest in Rural Development Administration, its successors or assigns the entire right, title and interest in and to the said improvements, inventions, applications, Letters Patent, rights, titles, benefits, privileges and advantages hereby sold, assigned and conveyed, or intended so to be.

AND, furthermore, Myeung-Sik LEE, Soo-Bong PARK, Won-Kyong CHANG, Jin-Ki PARK and Yong-Yun PARK covenant and agree with said Rural Development Administration, its successors and assigns, that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by Myeung-Sik LEE, Soo-Bong PARK, Won-Kyong CHANG, Jin-Ki PARK and Yong-Yun PARK and that full right to convey the same as herein expressed is possessed by Myeung-Sik LEE, Soo-Bong PARK, Won-Kyong CHANG, Jin-Ki PARK and Yong-Yun PARK.

The parties hereto acknowledge that they have specifically requested the present agreement to be drawn up in the English language.
