DEED OF ASSIGNMENT

extended, as fully and entirely as the same would have been held and enjoyed by me if this assignment and sale had not been made.

And I hereby authorize the Commissioner of Patents to issue any and all Letters Patent of the United States of America for said invention, or resulting from said application or applications therefor, to the said **Akzo Nobel nv**, as the assignee of the entire right, title and interest in and to the said application and invention.

And I further covenant and agree that I will at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title to said invention, or any Letters Patent that may be granted therefor, in **Akzo Nobel nv**, its successors, assigns or other legal representatives, and that if the said **Akzo Nobel nv**, its successors, assigns or other legal representatives desire to secure a reissue or extension or division of said Letters Patent, I will, upon request, sign all papers, make all rightful oaths, and do all legal acts necessary and requisite for the application for such reissue, extension or division, and the procuring thereof.
