## Assignment of Patent Rights

U.S. Serial No. 08/893,206

For good and valuable consideration, receipt of which is hereby acknowledged by Sound Science Limited Partnership, an Illinois limited partnership with an address at 3115 Ridge Road, Second Floor, Lansing Illinois 60438 ("Assignor"), does hereby sell, assign and transfer, effective as of April 1, 1998, unto POINT Biomedical Corporation, a California corporation with an address at 887A Industrial Road, San Carlos, California 94070 ("Assignee") and Assignee's successors and assigns, Assignor's entire title, interest, and right, including the right of priority, in, to and under Patent Application No. PCT/NL95/00028, which has been filed in the United States Patent and Trademark Office as a national phase patent application, and all corresponding applications, relating to certain ultrasound triggered drug delivery methods, and including any patents that may issue therefrom in any country, including without limitation in the United States, and any derivative patent applications and/or derivative works therefrom, including in each case all divisions, reissues, continuations, continuations in part and extensions thereof, and including in each case the right to sue for and collect damages for any past infringement thereof; and

For the above consideration Assignor will promptly upon request of Assignee, and Assignee's successors or assigns, communicate any facts known to Assignor respecting said application and the invention set forth therein, and to execute and deliver without further compensation any power of attorney, assignment, application, whether original, continuation, divisional or reissue, or other papers which may be necessary to desirable fully to secure to Assignee, and Assignee's successors and assigns, the inventions and any of them described in said application and all patent rights therein, in the United States and in any country foreign thereto, and to cooperate and assist in the prosecution of interference proceedings involving said inventions and in the adjudication and re-examination of said Letter Patent, provided the expenses which may be incurred by Assignor in lending such cooperation and assistance will be paid by Assignee.
