WHEREAS, I, Stefan Cramer, of Lampertheim, Germany, Rolf Gluth, of Blaustein, Germany, Thomas Schake, of Senden, Germany, and Brian E. Richter, of Bloomington, Minnesota, U.S.A., have invented certain new and useful improvements as described in an application entitled RADAR LEVEL GAUGE for Letters Patent of the United States, the application having been executed on even date herewith, and/or being identifiable in the United States Patent and Trademark Office by Serial No. 09/105,673, filed June 26, 1998; and

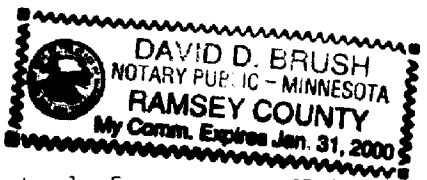
