WHEREAS I, *H. Walker Stockley, III*, residing at, 405 Thornhill Drive, Spartanburg, South Carolina 29301 have made an invention relating to a modified atmosphere package, which invention is described in an application for Letters Patent of the United States entitled, MODIFIED ATMOSPHERE PACKAGE FOR HIGH PROFILE PRODUCTS FROM UPWARDLY FORMED HEAT SHRINKABLE FILM, and signed by me on this day; and
