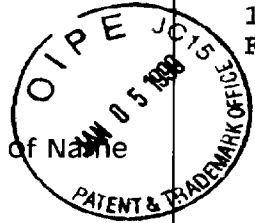

(a) for which an application for a United States patent was filed on February 26, 1998, Application No. D-29/084,185,


(b) for which an application for a United States patent was executed on _____, and
