

UTILITY PATENT

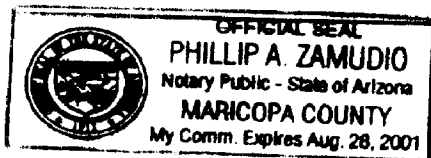
