WHEREAS, I, Weiyi JIA, (herein called "ASSIGNOR"), residing at Vista del Mar de Alturas, #103, Mayaguez, Puerto Rico 00680, am a co-inventor, along with William M. YEN, Lizhu LU, and Huabiao YUAN, of the invention "LONG-PERSISTENCE BLUE PHOSPHORS" for which we have filed provisional patent application no. 60/064,691 on November 7, 1997; and executed an application for a Patent of the United States, filed November 6, 1998, Serial No. 09/187,944;

WHEREAS, UNIVERSITY OF PUERTO RICO (herein called "ASSIGNEE"), organized and existing under the laws of Puerto Rico, and having a principal place of business at P.O. NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to me in hand paid, and other good and valuable consideration the receipt of which is hereby acknowledged, I, the said ASSIGNOR, has sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto the said ASSIGNEE, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said invention, and the said United States Application and all divisions, renewals and continuations thereof, and all Patents of the United States which may be granted thereon and all reissues and extensions thereof; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said invention in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority of the United States under the International Union for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models, inventors' certificates and designs which may be granted for said invention in any country or countries foreign to the United States and all extensions, renewals and reissues thereof;

AND I HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

AND I HEREBY covenant and agree that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

AND I HEREBY authorize the above-mentioned assignee or its legal representative to insert in this instrument the filing date and serial number of my said application or any other information that may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
