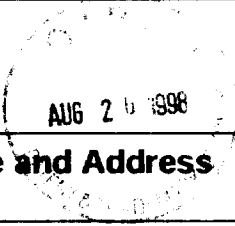

ASSIGNMENT AND AGREEMENT

For value received, I, Mitchell H.
