ASSIGNMENT

WHEREAS, I, Igor KOMSITSKY, residing at 1337 Wellesley Avenue, No. 4, Los Angeles, CA 90025, the undersigned inventor and the ASSIGNOR herein, have invented a new and unobvious APPARATUS AND METHOD FOR SUPPORTING AND/OR HOLDING A PAYLOAD, for which I have filed an application for Letters Patent of the United States, herewith, on December 19, 1998, which application has been executed by me concurrently herewith; and

WHEREAS, TA Mfg. NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) by the ASSIGNEE to me paid, and other valuable consideration, the receipt and legal sufficiency of all of which is hereby acknowledged, I, the ASSIGNOR, have sold and do hereby sell, assign, transfer and set over unto the ASSIGNEE, its successors and assigns, the entire right, title and interest in and to the inventions and all improvements thereon, in and to the application for Letters Patent thereon, in and to applications pertaining to or based upon the inventions and applications, including divisional and continuing applications and continuations-in-part, and in and to any and all Letters Patent which may be granted and issued on the inventions and applications, or any of them, not only for, to and in the United States of America, its territories and possessions, but for, to and in all countries and patent authorities and agencies foreign thereto, together with and including all priority rights based upon any and all applications in the United States of America covered by this Assignment.

ASSIGNOR also represents and warrants to ASSIGNEE that ASSIGNOR is the sole owner of the entire right, title and interest in and to the inventions, applications and Letters Patent to be granted and issued thereon, and has the full authority to make this Assignment; that the inventions, applications and Letters Patent to be granted and issued thereon have not heretofore been pledged, hypothecated or otherwise encumbered, and is in all respects free and clear; that the validity of the inventions, applications and Letters Patent to be granted and issued thereon have never been questioned; and that ASSIGNOR has not entered into any contract or made any commitment that will or may impair ASSIGNEE'S rights hereunder.

And for the above-named considerations, I do hereby agree that I will, at the request of said ASSIGNEE, execute any and all applications for Letters Patent for the inventions and any and all other papers and documents and do all other and further lawful acts that the ASSIGNEE may deem necessary or desirable to obtain Letters Patent on the inventions, to secure the grant of such Letters Patent and to perfect and vest in the ASSIGNEE the entire right, title and interest in the inventions, applications and Letters Patent.

And for the above-named considerations, I do hereby authorize and empower the ASSIGNEE, its successors and assigns, to apply for and obtain, in its or their own names, Letters Patent for the inventions before competent International Authorities, including the WORLD INTELLECTUAL PROPERTY ORGANIZATION, and in any and all countries foreign to the

United States in which applications for Letters Patent can be so made or Letters Patent so obtained.
