ASSIGNMENT OF DESIGN

WHEREAS, I, **Murray S. Cullen**, residing at 8 Del Andante, Irvine, California 92614, have invented an ornamental design disclosed in an application for United States Letters Patent entitled **VEHICLE-WHEEL FRONT FACE**, Serial No. 29/095994 filed on November 2, 1998;

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned and that I have not executed, and will not execute, any agreement in conflict herewith;

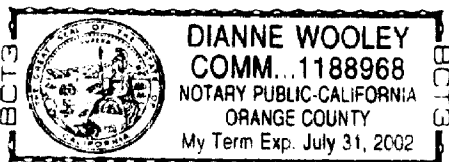
