LICENSE AND AGREEMENT

(Under E.O. 10096)

WHEREAS, I (~~we~~) ROY L. STREIT

of PORTSMOUTH, COUNTY OF NEWPORT, STATE OF

RHODE ISLAND

while employed by the United States have invented NEURAL NETWORK ARCHITECTURE FOR GAUSSIAN COMPONENTS OF
A MIXTURE DENSITY FUNCTION

identified as Navy Case No. 72241 and described in application for Letters Patent of the United States of America

executed by me (~~we~~) on 30 JUNE 19 95 ; and

WHEREAS, the Government of the United States, represented by the Secretary of the Navy and hereinafter referred to as the Government, is desirous of acquiring a license in the invention disclosed in said application and other rights and benefits herein granted; and

WHEREAS, the conditions under which the invention was made are such as to entitle the Government under Paragraph 1(b) of Executive Order 10096 to a license in the invention; and

NOW, THEREFORE, in consideration of the premises and of other good and valuable consideration the receipt of which is hereby acknowledged. I (~~we~~) hereby grant to the Government a nonexclusive, irrevocable, royalty-free license to make, have made, use and to sell said invention under any patents, domestic or foreign, which may issue thereon, with power to grant licenses for all governmental purposes; and


I (~~we~~) hereby agree that the Government shall have the exclusive right to prosecute said application, and I (~~we~~) hereby appoint the Secretary of the Navy, or his duly authorized representatives, my (~~our~~) attorney, with full power of substitution and revocation, to prosecute said application, to make alterations and amendments therein, to receive the patent, and to transact all business in the Patent and Trademark Office connected with the application, and to prosecute, conduct, and make adjustments and settlements of any interferences or conflicts in which said application may become involved.

I (~~we~~) hereby further agree to make, execute, and deliver to the Government any and all papers, documents, affidavits, statements, or other instruments that may be necessary in the prosecution of said application and of any substitution, division, or continuation of said application, or any application for reissue or extension of said Letters Patent, and to assist the Government in every way in protecting the invention as may be requested, provided that any expense arising through extending such efforts will be paid by the Government.
