



WHEREAS, we, Biljana Tadic, Robert E. Fischer, Robert M. Merritt, Neil L. Condra, and Dale S. Walker, are the joint inventors of "BEAMSPLITTER ADJUSTMENT DRIVE," application for United States Letters Patent Serial No. 09/177,932, filed October 23, 1998; and

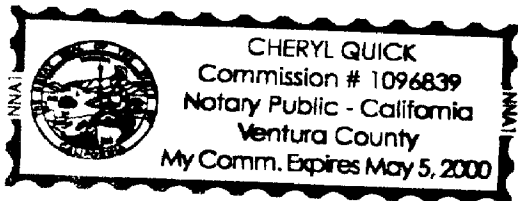




