WHEREAS, We, **GERALD A. BROWN, JEFFREY S. McNAMARA and DONALD D. PAGELS, Jr.**, have made certain improvements in a **PNEUMATIC CLAMP** for which we are about to make application for Letters Patent of the United States of America; and

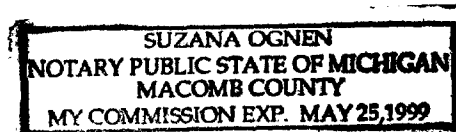
