# ASSIGNMENT OF UNITED STATES PATENT APPLICATION

WHEREAS, I, **Daniel Frederick White** of Lilburn, Georgia, have invented certain new and useful improvements in a **Methods and Apparatus for Touch Screen Touch Ahead Capability**, Docket No. 8210, for which I have executed an application for Letters Patent of the United States on 11/21/99; and
