WHEREAS, Joseph Carl Capek, 50836 Safari Drive, Granger, Indiana 46530 U.S.A.; and Norman Lee Hostetler, 2950 Plymouth-LaPorte Trail, Walkerton, Indiana 46574 U.S.A. And Assignors does hereby request and authorize the Commissioner of Patents and Trademarks, U.S.A., to issue said U.S. LETTERS PATENT, when granted, in accordance with this assignment.




