

ASSIGNMENT

WHEREAS, Samuel L. Davidson, whose address is 119 Fennell Drive, Monroe, Louisiana 71203 (hereinafter referred to as "ASSIGNOR") has invented certain new and useful improvements in a BOAT WITH CONVERTIBLE REAR CABIN AREA for which he is about to make application for United States Letters Patent;

ASSIGNOR further agrees, without any payment by ASSIGNEE other than expenses incurred by ASSIGNOR, to communicate to ASSIGNEE, its representatives or agents any facts relating to said invention, including evidence for interference purposes or for other proceedings, whenever requested; and execute and deliver on request all lawful papers required to make these provisions binding upon ASSIGNOR's heirs, legal representatives, administrators and assigns; and ASSIGNOR hereby warrants that, at the time of execution and delivery of this Assignment, ASSIGNOR is the lawful owner of the entire right, title and interest in and to said invention and said application, that the same are unencumbered, and that it has good and full right and lawful authority to sell and convey the same in the manner herein set forth.


