VOORIS**, have sold, assigned, conveyed, transferred and set over and do hereby sell, assign, convey, transfer and set over to **WOODSTOCK**, its successors and assigns, all right, title and interest in and to the said application and any inventions or discoveries (or both) disclosed and/or claimed therein, the rights to apply for patents on said inventions or discoveries (or both) in any foreign countries, the right to claim for such application the priority date of any earlier-filed application under any international convention treaty or agreement and modifications thereof providing therefor, all reissue, substitute, renewal, divisional, continuation and continuation-in-part applications for patents on said inventions or discoveries (or both) and extensions and renewals thereof in the United States and in any foreign countries, to the full end of the term or terms for which said patents may be issued, extended or renewed, the same to be held and enjoyed by **WOODSTOCK**, its successors and assigns, just as it would have been held and enjoyed by me if this Assignment had not been made.

I hereby authorize and request the Commissioner of Patents and Trademarks to issue all such U.S. Letters Patent to **WOODSTOCK** in accordance with this instrument Assignment.

I hereby request and warrant, in consideration of the premises that there are no rights or interests outstanding which are inconsistent with the rights and interests granted herein, and that I will not execute any instrument or grant

or transfer any right or interest inconsistent therewith, and I bind myself, my heirs, executors, administrators and legal representatives, as the case may be, to execute and deliver to WOODSTOCK, or its successors and assigns, any further documents or instruments and to do any and all further acts that may be deemed necessary by WOODSTOCK or its successors and assigns, to prosecute said application or applications for the said inventions or discoveries, and to vest in WOODSTOCK, its successors and assigns, the title herein conveyed, or intended so to be, and to enable such title to be recorded.

And I further covenant and agree, in consideration of the premises, that I, my heirs, successors, administrators and legal representatives will at any time upon request communicate to WOODSTOCK, or its successors or assigns, any facts relating to said inventions and discoveries and the history thereof known to me or my heirs, executors, administrators and legal representatives, and I will testify as to the same in any interference or litigation or other proceeding when requested so to do by WOODSTOCK, or its successors or assigns, it being understood and agreed that WOODSTOCK, or its successors and assigns, will compensate me for our expenses reasonably incurred in complying with such requests.
