ASSIGNMENT

I agree that I will without further consideration do all such things and execute all such documents as may be necessary or desirable to obtain and maintain patents for said invention in any and all countries and to vest title thereto in said assignee, its successors, assigns and legal representatives or nominees.

The Commissioner of Patents & Trademarks is hereby authorized and requested to issue said Letters Patent to said GLOBAL UPHOLSTERY COMPANY, the assignee of the entire right, title and interest in and to the same, for its sole use and benefit; and for the use and benefit of its successors and assigns, to the full end of the term for which Letters Patent may be granted, as fully and entirely as the same would have been held by the us had this assignment and sale not been made.
